### ENROLLMENT AGREEMENT: 2021-2022

***In order to hold your child's spot, the non-refundable enrollment deposit of \$300.00 must be enclosed with this contract and returned within 15 days. All checks should be made out to The Montessori School of Wooster. In the event that the School is unable to accept your child's application due to full enrollment, you will be informed by June 1, 2021 and your deposit will be refunded to you.***

This agreement is made between the **Montessori School of Wooster** (hereinafter the "School") and \_\_\_\_\_ (hereinafter the "Parent(s)"). In consideration of the Parent(s) agreement to the terms and conditions set forth below, the School will accept \_\_\_\_\_ (hereinafter "Pupil") as a pupil for the 2021-2022 school year. This contract is for one year only. Successful completion of the current academic year and recommendation of the School is required for re-enrollment in subsequent years. Your child must be reliably potty-trained. If your child is not potty-trained by the first day of school, please let us know and we can delay your enrollment or transfer your child to an appropriate program. Your enrollment deposit will be held on your account until your child is fully potty-trained and an opening in your desired program exists.

The Parent(s) understands that in signing this Enrollment Contract for the school year 2021-2022 the undersigned are agreeing, on behalf of themselves and the student, to accept the policies, rules and regulations of the School as stated in the current handbooks, which rules and regulations may be amended from time to time. Please understand that withdrawing your child before the end of the school year does not relieve you of the obligation to pay tuition for the entire school year. The only condition releasing the Parent(s) from this contractual agreement is a move from the Wooster area or withdrawal pursuant to the *Procedure for Student Withdrawal* policy, which is attached hereto and incorporated herein. On rare occasions, we find that the Montessori environment is not a good match for a particular child. The school reserves the right to cancel this contract if the school determines that it is in the best interest of the child or the school to do so. In such cases, no further tuition will be due.

If any payment is more than 30 (thirty) days overdue, the child may be excluded from the classroom. The Parent(s) further agrees to pay all costs, expenses and reasonable attorney's fees that may be incurred or paid by the School in bringing any action or proceeding for the collection of any unpaid balance pursuant to this Enrollment Contract.
